We find that the interest accruing on the Fair Hill School fund up to 1st Dec. 15th 1865, fully competent to meet the present indebtedness for school purposes in Virginia, and to keep up the necessary schools through the ensuing year.

We propose the sum of Six Hundred Dollars as the sum necessary to be raised to meet the expenses of the ensuing year.

1866 The Trustees of the Fair Hill Fund were directed to use the interest arising from that Fund as it becomes due, in payment of the expenses of schooling the children of Virginia Friends, as directed by this Meeting in adopting the report upon that subject.

The Committee appointed at last sitting, in relation to a change in the mode of appointing members of the Meeting for Suffrage, reported that the way did not open to take any action on the subject at this time, but that it be referred to the consideration of the Yearly Meeting next year, with which the Meeting united, and the subject was referred accordingly.

The Clerks were directed to have 2000 Copies of the Extracts from the proceedings of this ^{Meeting} printed for distribution amongst our members, and the Treasurer of the Yearly Meeting was directed to pay the expenses, of printing these ^{and the} extracts of Women's Meeting, and have the Extracts of both Meetings forwarded as soon as practicable, by mail or otherwise to some suitable persons near the place at which each of our monthly Meetings is held.

The Committee appointed at a former sitting to prepare Essays of Spirituality to the several Yearly Meetings, with which we correspond, produced one, embracing the Minutes of the exercises of the Meeting which upon being read, was satisfactory to the Meeting, and the Clerk was directed to transcribe it, sign it on behalf of the Meeting, and forward a copy to the Yearly Meeting of Philadelphia New York - Genesee, Ohio, and Indiana respectively.

The Standing Committee on the Boston Lot procured the following Report, which was satisfactory, and that Committee was directed to pay the balance of \$67⁵/₁₀¢ now in their hands to the Treasurer of the Yearly Meeting Viz;

The Standing Committee on the Boston Lot report: That after paying all expenses thereon, they find a balance of \$67⁵/₁₀¢ in their hands, which is subject to the disposal of the Yearly Meeting.
