Page 89. The paragraph beginning "In all cases when a Monthly, ^{et cetera}" shall be changed to read—
"Men and Women shall deal with offenders of their own sex separately, and when satisfied that such is the proper course shall bring the case before the Monthly Meeting. In all cases ^{et cetera} (to the end of the paragraph as at present).

Page 87 the paragraph beginning "Of the persons removed, ^{et cetera} and ending "before they can be fully accepted by the Women's Meeting," shall be omitted.

Pages 89 and 90. Omit from the beginning of last paragraph on page 89, "When females violate, ^{et cetera} to the beginning of the last paragraph on page 90. "It is not expedient," ^{et cetera}.

Pages 92 and 93 Omit paragraph on page 92, beginning "When the appellant, ^{et cetera} and ending on page 93, "inform the appellant of the result."

Page 127 The last paragraph beginning "Women's Meetings are also to raise," ^{et cetera} shall be changed to read "Women's Meetings may also raise," ^{et cetera}.
