PEACE CONFERENCE of all bearing the name of FRIENDS

By minute 88 of London Yearly Meeting 1916 the Yearly Meeting referred to the Meeting for Sufferings a proposal which had "met with a good deal of support", "that a Conference be held of all who bear the name of Friend with the object of giving full consideration to the deeply important subject of how to secure a general and lasting peace". The Meeting for Sufferings was asked to consider how far the proposal "is desirable and practicable", and was empowered "if thought well to take steps to carry it out". At a meeting held on the 1st of 9th month 1916 the Meeting for Sufferings received from its Peace Committee a minute stating that the Committee is "unanimous in thinking that such a conference should be attempted". The Committee added "In it we should endeavour to lay down the lines of future work in defining for ourselves and expressing to the Churches and to the world the mind of Christ as we understand it, in stimulating workers and considering policy for the future". The Meeting decided to "attempt to arrange for the holding of such a Conference, probably in England, shortly after the close of the War", whenever that may be. This may, of course, mean in the autumn of 1917 or even sometime in 1918. A committee will shortly be appointed to commence the work of organization. This is sent by way of preliminary information to Yearly Meetings on the American Continent and to General Meetings of Friends in Australia and New Zealand.
