2. A report on insurance carried on meeting-house furniture;
3. And from Hopewell Meeting information regarding the insurance the Hickute Friends carry on the house used in common by the two branches of Friends.

The report on the Insurance carried by each Monthly Meeting, which is herewith attached, was read and approved.
