Dear Friends:

The Trustees of the Miles White Beneficial Society, in conformity with its Act of Incorporation, submit the following statement of its operations for the past year.

Since the last report there has been no change made in the investments of the Society. The cash balance on hand to mo 1. 1901 was 2952.72. There has been received as interest on bonds 54.15. and as interest on loans to individuals 51.01. and on account of principal of loans 221.51. Making the total receipts \$8,640.24 of which there has been distributed, as follows,
