The Treasurer, in accordance with article 3 of the By-Laws, presented the following report, which was referred to the Finance Committee, to be audited. (See next page.)

The Treasurer also reported that all the loans were in good condition, and interest and charges properly paid, with the exception of the loan to Dr. Ledbetter of Greensboro, N. C., who owes his loan of \$300.00 together with \$195.00 interest and charges, and ^{apparently} was making no effort to reduce it. The Treasurer was authorized to state that the Board required a settlement.

The following report was ordered to be forwarded to the Baltimore Yearly Meeting of Friends, after having been signed by the President and Secretary. (See opposite page.)

The Secretary reported as follows,-

From reports received from various schools, it is shown that Belvidere Academy used their appropriation of \$100.00 to assist in paying the tuition of 28 students. That Up River Friends School used their appropriation of \$20.00 to have the term extended 14 weeks. That White Plains School had their term extended for 3 months, benefiting about 40 children. That Southland College had assisted 12 students. That Guilford Graded School had their term extended, thus benefiting an enrollment of 134 students. That Guilford College had assisted 56 students during 2 terms. That Rich Square School had had a successful year, and was now known as the West Union School, within the limits of Rich Square Monthly Meeting. That Friendsville Academy had used their appropriation to reduce the rate of tuition to a needy set of 126 scholars, of whom 52 were Friends. That Cedar Grove School has used their appropriation of \$100.00, together with \$119.00 received from patrons, to extend their school year to 8 months, thus benefiting 62 pupils, of whom 31 were Friends.
