The Collection of 4 Clifts Herring & Elk Ridge Meetings amounting to 8 L 10 S Currency was brought to this Meeting & put in to the hands of Joseph Galloway for further Service

This meeting appoints Joseph Cowman Gerrard Hopkins Joseph Galloway Sam^l Robertson W^m Harris Doc^r Richard John Aquila Carr Sam^l Hopkins & Henry Pierpoint to attend the service of 4th next Yearly Meeting of friends on the Eastern Shore with Acc^t of the Stiles of our Quarterly Monthly & weekly meetings held on the Western Shore and any other services needfull to friends
Robert ward & Elizth his wife did offer a paper ^{to this Meeting} Condemning their Out going in way of Marriage which being Read and allowed of by the said Meeting and they ^{also} allowed of as Members of our Society

At a Quarterly Meeting Held at Herring Creek 4th 2nd of 9th Mo^o 1748

It appears by acc^t brought in from the Monthly Meeting belonging to this that they are Constantly kept and that some Weekly Meetings there to belonging are duly kept on times appointed some others not so satisfactory Acc^t as could be desired & some no account

Joseph Galloway makes it appear to this Meeting that he has laid out L 25: 18: 6 of 4th m^d Stock towards the Repairs of 4th yearly Meeting House West River and of there still remains L 7: 16: 6 Paper Currency & four Pistols which Money is to be put in to the hands of Jo^l Cowman and Gerrard Hopkins and they to exchange it in 4th L^o offices at annapolis for 4th further Service of friends that Balance of L 48 = 15 = 0
