Johns Hopkins & Mary Crocket appeared before this Meeting and Declared their intentions of Marriage with Each Other it being the second time and those Persons appointed to inspect their Cleanness from marriage engagements Consent of Parents &c. do make Report that they find nothing to hinder their further proceedings they are therefore Left to their Liberty to accomplish their said intentions at a Convenient Time and Place; Joseph Galloway & Joseph Cowman are appointed to assist in that affair

by ac^{ts} from Gunpowder it appears their Monthly Meetings is Constantly Kept as also their weekly Meetings since y^e Last Account
by ac^{ts} from y^e Monthly Meeting Held at y^e Elft it appears that y^e Monthly meetings have been Constantly Kept on times appointed

Appointed and y^e Weekly meetings there to belonging some of w^{ch} are Constantly kept on Days appointed some not so Constantly Kept & some Other no Account

Our friend George Matthews Communicated to this Meeting a Certificate from y^e Monthly Meeting of friends held at Manaquepe which was Read and approved of by this Meeting

Anne Moore & Companion Likewise Communicated their Certificate from y^e Monthly Meeting of friends held in Fairfax County in Virginia which being Read and Approved of
This Meeting Appoints Joseph Galloway & Daniel Richardson to provide Certificates for them and send them after them

Att. a Quarterly Meeting Held at Herring Creek y^e 2nd of 3rd Month 1750

From Gunpowder Act is that their Meetings are Kept up though not so well attended as some friends could wish Love & Unity is in some Good Degree Maintained & where things appear disorderly Care is taken for Amendment

From West River Act is their Monthly Meetings are Constantly Kept as also their weekly Meetings / Herring Meetings but is their Meetings are Constantly Kept on first Days but not Constant on fourth Days / Elft Meeting no Ac^{ts}

A Certificate for George Matthews & another for Anne Moore was produced to y^e Monthly Meeting at West River there Read approved of and Signed & it the Sense of this Meeting that all Certificates shall be from some Publick Meeting for the future

Friends of Gunpowder Monthly Meeting proposed to this the removing the Quarterly Meeting from Herring Creek to West River Meeting House w^{ch} Proposition this Meeting has having Considered is of Opinion that Removing the Meeting will be of more Service - and more in the Body of friends
