Daniel Richardson and Margaret Hopkins appeared in this Meeting and Declared their Intentions of Marriage with each other it being the Second Time, and the Enquirers appointed by our Last Monthly Meeting held at West river informs this Meeting they have made the Needful Enquiry and find no just Cause to hinder their further proceeding to the accomplishment thereof. nor any person known therefore they have the approbation of this Meeting to appoint time and place at their own Discretion for Accomplishment thereof, and that Philip Thomas and John Talbot assist them with Certificate and Needful Care thereto Relating
