and love in some good degree subsists amongst friends  
and as to widows & orphans case is taken

Oliver Matthews produced to this meeting  
friends collection for Gunpowder monthly meeting  
amounting to the sum of ten pounds twelve shillings  
& sixpence which this meeting advises to be put into the  
hands of Sam<sup>l</sup> Robertson together with the collection  
of West River monthly meeting the whole amount

Abraham Olmister produced to this meeting  
an acct. of nine shillings & three pence which he expended  
for the use of friends this meeting advises Sam<sup>l</sup> Robertson  
to pay said sum out of friends stock

The queries has been read and answered  
in this meeting by which itt appear there is a great neglect  
this meeting advises friends to be more careful for future  
non further business this meeting (concludes)
